#### **Executive Committee (EC) POSITIONS: Serving Year 2018**

- 5 officers (President, Vice-President, Secretary, Treasurer and Communications Director)
- 10 Executive Committee members.

(All EC positions are 1-year service term)

#### **Board of Director (BOD) POSITIONS: Serving year 2018 thru 2020.**

- 2 BOD Positions with 3-year term.

As per the guidelines in the GATS by-laws (available at

<http://www.gatamilsangam.org/images/bylaw.pdf>) regarding election and voting procedures

nominations are invited on behalf of the aspiring volunteer candidates willing to serve GATS in the EC and BOD. Any member of GATS in good standing as of September 1, 2017, meeting all the requirements as stipulated in the by-laws, is eligible to contest for any of the positions in the Executive Committee or the two positions for Board of Directors.

## Guidelines:

- A member can nominate only one candidate for a single post.
- A candidate can be nominated for only one post.
- Executive Committee Candidates must be active members in good standing and who have been a paid member of the Sangam for 2 consecutive years as of September 1, 2017 or a life member in our Sangam for at least 12 months by September 1, 2017.
- Board of Directors positions require at least 5 consecutive years of paid membership as of September 1, 2017.
