



Nominations for GATS Board of Directors (BOD) and Executive Committee (EC) For the Year 2021

Bylaw IV – Section-3: Nomination Process: A GATS member in good standing can only make one single nomination, including self-nomination. The nominating member shall submit nomination only with the consent of the candidate, with an email copy to the Election committee. A candidate shall be nominated for only one post for EC or BOD at a time. A candidate can withdraw his or her nomination and be nominated for another post during the nomination period according to his or her choice.

Important Reminder: Please note that the GATS Board of Directors has authorized this year's elections to be conducted using electronic ballots due to all GATS activities being impacted by COVID-19 pandemic. It is important for all members to have their household voter information updated in the GATS membership database. GATS will not be liable for anyone's nomination or voting rights affected by failure to do so in a timely manner. Thanks for your understanding and kind cooperation!

General Instructions: Please use a separate form for each nomination. Do not nominate multiple persons in a single form or multiple posts for single person. If you are not self-nominating, attach an email copy that you took consent of the person whom you are nominating. Without properly completed nomination form and valid supporting documents, the nomination will be rejected.
